1. The student driver will follow all vehicular laws. The speed limit on campus is 5 MPH.
2. No nuisance activity is allowed on campus (blowing horns, rolling tires, diesel motor smoke production, loud music, etc.).
3. When buses begin to exit, student drivers must wait until all buses exit; no cutting into the bus lines.
4. The student driver is responsible for all persons, items, and activities in the vehicle. Vehicles are subject to search.
5. Student drivers must only park in their designated space.
6. **Student debts need to be cleared before a student can receive their parking pass.** This includes class dues, textbooks, calculators, lost items, etcetera. Student debt can be viewed in the Home Access Center.
7. **Driving to Sussex Technical High School is a privilege.** Not abiding by the rules can result in fines, the vehicle being towed at the owner's expense, disciplinary action, and /or loss of driving privileges with no refund of the parking pass fee.
